

Franklin Recreation Meeting June 21, 2017 (draft)

Bridget Thompson called the meeting to order at 7:12.

Bridget motioned to approve the meeting minutes from June 5. Bridgette seconded. The motion passed.

The Treasurer reported that the 27 players who attended the Little League Challenge raised \$710. There are still a few bills that need to be tallied before reporting the final amount raised by the event, the number is expected to be around \$320.

Miriam proposed a Franklin 5K race. Her vision includes a kickoff party at the town green, then a shuttle to take runners to the starting point at the town beach. The racers would run up Gallop Road to Middle Road and on Middle Road toward town. The race would end on Middle Road close to town and the racers would walk back to the town green for an ending ceremony.

Discussion followed about race dates, entry fees, t-shirts, medals, theme, age categories, a fun run for kids, and the possibility of a triathlon. A group will meet at 9am on July 5 to further work out details.

To date there has been one applicant for this position. The applicant will be asked to meet with the board in July.

Recreation Board Members

There is a potential need for two new board members. A call for letters of interest will be posted in July.

Sponsorship/Fundraising

To date, 45 tickets have been sold for the Lake Monster Fundraiser. Franklin Recreation/Little League will earn \$3 per ticket sold.

Discussion about whether sponsorship letters should be sent out more than once per year.

Summer Programming

Insurance/Camps: Bridget met with the Town Selectboard to discuss possible insurance options. Going forward, for programs run through Franklin Recreation, an exposure fee will be assessed to provide workman's compensation for the person(s) running the program. If the individual(s) does not have liability insurance, he/she will have to sign a hold harmless form and all attendees will need to have a signed liability waiver.

Bus Trips: Franklin Recreation will provide bussing to Granby Zoo on August 8, and Snow Farm Winery for a concert on August 10. Discussion about what to charge and how to have interested people sign up. Details will be announced in July.

Community Event: Discussion about what type of activity to provide for the community event. Research will be conducted and discussed at the next meeting.
