Minutes of the Franklin Selectboard Town Clerk`s Office June 7, 2017 @ 7:00 p.m.

The Meeting was called to order at 7:00 p.m. by Selectboard Chair Peter M. The Pledge of Allegiance was recited by all present.

Guests: Robert Bender, Gordon Bender, John Barrows from Franklin Watershed Committee and Bridget Thompson from the Recreation Department

Agenda Amendments: Elevator inspection contract has been scratched off the agenda.

Public Comment Period - The Bender's asked if there was any update on the water break. The SB has no new news. The water meeting is Monday, June 12, 2017.

Approval of Minutes from the May 17, 2017 meeting – Brooks S/Ed R made a motion to accept the Minutes with one correction (line 104 has a misspelled word - advise). Vote taken, All in favor and the motion passes. The Minutes of May 17, 2017 are approved.

Highway Department -

- Main Street ROW resident concerns The Bender's who reside at 5225 Main Street have
 concerns about the public and delivery trucks parking in front of their brick home and blocking
 their driveway. They have put up "Do Not Block Driveway" signs. They are asking the SB for
 help. The SB agreed to discuss their options. Ed R agreed to talk with Bill Mayo, the store
 owner about the delivery trucks. Also, the Bender's spoke about the speeders on Main Street.
- Road Foreman job description posting notice draft Peter M said the SB needs to meet with Jeremy to go over what the Foreman position entails. Yvon D talked to Jeremy and he is ready and willing to talk with SB any time. Peter M suggested June 12, 2017 @ 7:00 p.m. After the water meeting. Lisa the Town Clerk needs to warn this meeting.
- Sign the Better Roads Grant agreement for Webster Road The Grant is for \$6328 total with a 20% match from the town. Jim from the State should look at the culvert. Ed R/Yvon D made the motion to sign the Grant Agreement. Vote taken, all in favor, motion carried. Pete M signed the Grant Agreement.

FWC - John Barrows regarding Swamp Road culvert work - There are three culverts involved. FWC is doing the stonework and there is a 20% match needed from the Town. John Barrows went over the work to be done. He has received three quotes for the job description. 1) Shumway Landscaping from Swanton, VT quoted \$1943.06 2) Charles Havreluk from Fairfax quoted \$5630. 3) Phillip Pelkey quoted \$10,722. No Permits are needed. Discussion ensued. Brooks S/Ed R made the motion to accept Bid #1 from Shumway Landscaping. Vote taken, all in favor, motion carried.

Town Clerk concerns

Rec Dept. Insurance - Bridget Thompson was present to discuss making sure the Rec.Dept.
 Employees and Independent Contractors have the right kind of Insurance. Also, the Rec.
 Board Members need to be appointed for certain terms. Two positions need to be filled. The

- Rec. Committee will make recommendations to the SB. Brooks S/ Yvon D made a motion for the Rec.Dept. to use 1099 Independent Contactor status for associates and to cover the costs of all exposure out of fees received. Vote taken, all in favor, motion carried.
- Procurement Purchasing Policy Lisa has been working on this as it is needed for Grant writing. Drafts need to be reviewed. Discussion will follow at the next meeting.
- Dog complaints A complaint dated June 6, 2017 came in from Carolyn Kittell. The incident happened on June 5, 2017. Carolyn's dog (Henry) was bitten by Irene Robear's dog. Peter M suggested the SB send a letter to the Robear's and ask Dennis Demar (dog catcher) to pay the Robear's a visit. Also, on May 19, 2017 Arnold Lagrow complained that Mark Comb's dog does his daily BM on Lagrow's property. Peter M suggested the same response; a letter to Comb's and a visit from Dennis Demar.
- Old wooden door in the attic Eric Gerard has offered \$50 for the door. A SB member will look at the door to help determine if they want to sell it and what the value may be.
 - Highway internet costs it will be \$75 for the modem and \$38.95 per month for the wifi service. (a total of \$542 for the first year). Discussion ensued. No action taken.
 - Dog warrant this warrant allows for dogs to be picked up if they are not registered. Brooks S/Ed R made the motion to sign the dog warrant. Vote taken, all in favor, motion carried. The warrant was signed by Peter M.

Brooks S/Yvon D made the motion to sign the letter. Vote taken, all in favor, motion carried. Peter M signed the letter.
