Peter Magnant called the meeting to order at 7:02 p.m. The Pledge of allegiance was said.

No public comments.

Appointment of boards:

- Chair of Selectboard: Kyle/Wayne nominated Peter Magnant. All members voted in favor, motion passed
- Vice-Chair of Selectboard: Kyle/Wayne nominated Yvon Dandurand. All members voted in favor, motion passed.
- Road Commissioner: Wayne/Peter nominated Kyle Lothian. All members voted in favor, motion passed.
- Zoning Administrator: Kyle/Yvon nominated Robert Irish. All members voted in favor, motion passed.
- Planning Commission: Peter/Andrew nominated Greg Bouchard, Howard Deuso, and John Ho for 3 year terms. All members voted in favor, motion passed.
- Zoning Board of Adjustment: Peter/Wayne nominated James Pivorotto and Chris O'Shea for 3 year terms. All members voted in favor, motion passed. One position is still open for another member. Thank you letters for Johanna Crane Godin and Christopher Wagner were reviewed and signed by Peter.
- Animal Control: Yvon/Wayne nominated Denis Demar. All members voted in favor, motion passed.
- Keeper of the Clock: Kyle/Peter made a motion to appoint Eric Gerrard as keeper. Marshall has knowledge of the clock and will train Eric. All members agreed. A thank you letter to Cliff Bullis was reviewed and signed by Peter.
- Northwest Regional Planning member positions added to the list: Peter/Wayne made a motion to reappoint Yvon Dandurand and Clark Hubbard to the board. All members voted in favor, motion passed.
- T.A.C. position added to the list: Peter Magnant will continue to be the member of this board.
- All other positions as listed on appointment sheet remain the same as approved by the board.
- Reviewed the zoning and permit fees, Equipment rental fees for mutual aid. No changes made.

Franklin Fire Department has asked to make Square Rd a one-way street for the pancake breakfast on March 10. Signs will be installed directing traffic. All members agreed.

Peter voiced that the town residents were pleased with how town meeting went and with the work of the board.

- Will plan to hold public meetings on the Dewing Bridge issue and Sand Shed project as the board continues to finalize the projects. The town clerk will look into the necessary permits with the engineer working on the bridge construction and submit the building permit to the ZA for the sand shed. Quotes will be requested for the sand shed funding.
